A Word From The Grand Knight

I believe that someone saw the advertisements for the event and informed the powers that be. We chose to contact The Supreme Council for help in understanding why this happened. It was brought to our attention that in our past, we had a similar problem with another rental years ago, at that time it was suggested to us to make sure that political rentals did not use the K of C logo or moniker in any way shape or form, at that time we changed our rental agreements to reflect DEX HGHTS Inc. rather than our
